## Whole School Emergency School Closure Procedure

(in adverse weather conditions, the failure of an essential service or in the event of an outbreak of illness)

### Actions

The Managing Director will, in consultation with the Board of Directors, decide whether a closure is necessary. He will then inform the Heads of Schools who will inform the teaching staff, administration staff and caretaker who will contact the cleaning staff. In the event of the Educational Director being unable to contact staff or school, then the decision to close will be made by the most senior member of staff available.

Parents will be rung by the teaching staff who are present and the administrative staff.

The Bursar will inform the bus drivers that the school bus service will not run until further notice. The bursar will also inform all parents by e-mail and issue a daily bulletin.

### Possible Emergency Conditions

- Heavy Snowfall or Hurricane
- Flooding
- Mains water failure
- Electrical failure
- Illness

Staff living nearest to school are requested to make every effort to reach the school in the event of bad weather in order to attend to children who may turn up.

### Important points

- All schools must keep accurate and up to date emergency contact files on all their children.
- All managers and teachers should have correct telephone numbers for members of staff. These should be kept at home.
- It must be understood that it is impossible to prepare for every situation and eventuality. A good deal of flexibility and initiative must be built in.
- Parents should know that in the event of any emergency condition that they should check their emails.
